6.8 Transfer Credits (“TC”) Policy

~~When a student brings credits from other institutions, these credits will be noted with a grade of “TC” (Transfer Credits). Transfer credits (“TC”) are included in the calculation of the maximum allowable credits and completion rate requirements as credits attempted and credits earned for SAP calculation. Since these courses will not carry grades, they will have no effect on GPA calculations. The student’s new normal program length will be shortened to reflect the transfer courses and the Maximum Time Frame will be recalculated.~~

~~A transfer student must complete at least 50% of the credit hours required by their program of study at VIU. For example, a transfer student in VIU’s graduate degree program would have to complete at least 18 of the required 36 credit hours at VIU. This means that prior to enrollment, a graduate degree student may transfer up to 18 semester graduate credits from other accredited institutions and apply them towards a graduate degree program at VIU at the discretion of the institution. A graduate level certificate student may transfer up to 9 semester credit hours of graduate credit hours from other accredited institutions and apply them towards a graduate level certificate program. A minimum of a 3.000 grade point average (“B”) out of 4.000 must have been earned on all graduate level transferable credit hours. An undergraduate degree student may transfer up to 60 semester credit hours from other accredited institutions and apply them to their program. A minimum of a 2.000 grade point average (“C”) out of 4.000 must have been earned on all undergraduate level transferable credit hours.~~

~~Transferable credit is considered upon the request of the student at the time of initial registration. Graduate students who want to apply courses taken at another college/university toward their VIU graduate degree must understand that the following criteria must be met in order to be considered for transfer of credit:~~

7.18.2 ESL Program Specific Attendance Policy

~~Fairfax University of America’s Intensive English Program’s (IEP) attendance policy requires all students to attend their scheduled classes and to arrive to class on time. The program recognizes that attendance in class alone is not sufficient to demonstrate learning/achievement of learning outcomes; however the university does recognize a correlation between attendance and academic achievement. Therefore, regular and punctual attendance in all courses is expected for students enrolled at the university.~~

~~The university maintains meticulous attendance for all students across all courses/programs. While attendance is recorded and monitored, there is no required minimum attendance for ESL students. Missing classes would not automatically lead to course failure. Instead, students advance from level to level based upon their academic progress in the course(s).~~

7.18.2.1 Absences for ESL students

~~ESL students should strive to maintain satisfactory attendance, and should miss class only when it is absolutely necessary. In instances in which personal circumstances sometimes keep students from attending all classes, it is the student’s responsibility to notify the course instructor prior to missing class.~~

In cases where advance notification is not feasible (e.g., accident or emergency), the student must provide notification as soon as possible after the absence. This notification should include an explanation of why a notice could not be sent prior to the class.

Faculty are not obligated to allow students to make up work from missed classes. To request to make up any missed work, the student would need to fill out an "excused absence documentation submission form." This form can be obtained from the program director or on the SLS website. The student must include any doctors' notes along with all supporting documentation and give all documents to the course instructor who will provide a copy to the Dean of the School of Language Studies.

Upon review of the submitted documents, and consulting with the program director as needed, the instructor will determine if any makeup coursework can be completed. Where appropriate, the instructor will provide the student with an opportunity to make up any quiz, exam or other work that contributes to the final grade or provide a reasonable alternative by a date agreed upon by the student and instructor.

ESL students should strive to maintain satisfactory attendance, and should miss class only when it is absolutely necessary. In instances in which personal circumstances sometimes keep students from attending all classes, it is the student's responsibility to notify the course instructor prior to missing class. In cases where advance notification is not feasible (e.g., accident or emergency), the student must provide notification as soon as possible after the absence. This notification should include an explanation of why a notice could not be sent prior to the class.

7.18.2.2 Lateness in ESL Classes

All students are expected to be in class on time. Late attendance is disruptive to both the instructor and students. If a student is late for class more frequently than what the instructor(s) considers acceptable, the instructor will report the issue to the program chair or designee for appropriate disciplinary action.

All students are expected to be in class on time and remain for the entire class period. Late attendance is disruptive to both the instructor and students. Also, students who arrive late may miss valuable class activities. For administrative purposes, students who are...

- ...0-10 minutes late will be recorded as *present*,
- ...11-30 minutes late will be recorded as *late*; and
- ...30+ minutes late will be recorded as *absent*.

Instructors have the right to mark a student absent if the student: is not physically present in class for more than 30 minutes per class at any point; or is physically present, but not participating or being disruptive.

If a student is late for class more frequently than what the instructor(s) considers acceptable, the instructor will report the issue to the program chair or designee for appropriate disciplinary action.

7.18.2.3 ESL Students on an F-1 Visa

In addition to the university's attendance policies, F-1 students have additional requirements that they must follow with respect to Federal regulation, which include maintaining satisfactory attendance each term/semester. Students who do not maintain the minimum required attendance risk having their I-20s cancelled, leading to a loss of visa status; thus, failure to maintain satisfactory attendance may result in loss of status. F-1 visa students must continue attending classes to maintain their visa status even if they have missed more than the permitted number of classes and will receive a failing grade. F-1 students who are having difficulty maintaining attendance are urged to meet with their advisor, the School head and/or the PDSO of International Student Services as soon as possible to avoid loss of visa status.

1.1. Introduction & History

Fairfax University of America (FXUA) was founded in 1998 as a non-profit university in the Washington, DC area to provide quality, affordable education that prepares students for relevant and meaningful careers. Today students from all over the world choose to pursue their education at the university in a variety of different degree and non-degree programs at the undergraduate and graduate levels across its academic schools: the School of Business, the School of Computer Information Systems, the School of Education, and the School of Language Studies. The location of the university, outside of Washington, DC makes it a prime location for students interested in studying in these fields, providing many opportunities for experiences outside of the classroom to enrich their learning experience.

The University's Timeline

Below are some historical milestones achieved by Fairfax University of America:

Founding of Fairfax University of America 1998-2006

Fairfax University of America was founded in 1998 and was certified to operate in Virginia by the State Council of Higher Education of Virginia (SCHEV). At its founding, the first programs offered by the university included the Master of Business Administration (MBA) Program, as well as its English as a Second Language program. In 1999, the university was incorporated as a non-profit corporation and obtained tax exemption as a 501(c)3 non-profit organization by the US Internal Revenue Service (IRS). FXUA received authorization to offer diploma and certificate programs in business and computer science by SCHEV in 1999. In 2000, FXUA was granted permission to issue I-20s for F-1 and M Visa applicants from the Immigration and Naturalization Service. Also in 2000, the university opened two undergraduate degree programs: the Bachelor of Science in Business Administration (BBA) and the Bachelor of Science in Computer Science (BCS). In 2003, FXUA was authorized by SCHEV to offer its second master's program: the Master of Science in Information Systems (MIS). The university held its first commencement on May 4th, 2006 with 20 graduates in attendance.

Coming into Focus 2008-2014

In 2008, FXUA was granted accreditation from the Accrediting Council for Independent Colleges & Schools (ACICS), ~~which is recognized by the US Department of Education and the Council on Higher Education Administration (CHEA). Also in~~ In 2008, a third master's degree program was added: the Master of Science in Computer Science (MCS). On April 23rd, 2008 the Virginia General Assembly House Joint Resolution Committee presented the university with a letter commending the university "on the occasion of its accreditation and 10th anniversary." In 2009, the university was approved to offer new programs including the Master of Arts in TESOL and the Graduate Certificate in TESOL. In 2011, FXUA successfully received ACICS re-certification in December. In 2013, the university was approved to open new master's degrees, and the School Education was formed. In 2014, FXUA opened three new master's degree programs: the MS in Accounting, the MS in Project Management, & the MS in Applied Linguistics. In 2014, a graduate certificate in Project Management was also added.

In 2015, the university opened its new Campus at 4401 Village Drive Fairfax. Also in 2015, the university was recognized as an authorized provider by the Project Management Institute. In May 2016, FXUA successfully received renewal of ACICS accreditation. In 2017, the intensive ESL program was accredited by the Commission on English Language Program Accreditation (CEA).

Moving Forward 2019-Present

Fairfax University of America experienced positive transformation and maturation in 2019. From 2019, the university emerged into a new and exciting phase in its history. The Board of Trustees decided that on January 1, 2020, the university's name would formally change to Fairfax University of America (FXUA). The name change was representative of the institution's history in the Fairfax Virginia area, where the campus has been rooted since its founding. As a university, FXUA was poised to move forward and creates its new future representing its maturity, accessibility, and excellence reflected in its mission. The next chapter in the university's history is yet to be written.
